Andrews / Spicer Collection (Collection 250)

Scope and Content

The Andrews and Spicer names are synonymous in Seventh-day Adventism for missions. John Nevins Andrews (1829-1883) was the first official missionary sent by the Church to a foreign land. This occurred in 1874 when John and his two children traveled to Switzerland. Over the next nine years John and his family labored there, losing daughter Mary to TB in 1878 and John himself, also to TB, in 1883. John's grandson, also John Nevins Andrews (1891-1980), was a pioneer to the Tibet region of western China from the late 19teens to the early 1930s. The younger Andrews wife, Dorothy (1903-1979) was the daughter of William A. Spicer (1865-1952), one of the most recognized Adventist leaders of all time, a world-traveler and a great proponent of missions. This collection contains documents, letters, and writings about all of these people plus members of their families.

This collection contains the largest concentration of known John Nevins Andrews letters. There are 29 letters written by Andrews to various family members, largely his uncle on his mo, Edward L. Pottle. There are also several previously unknown letters written by Ellen White in this collection. While the significance of the collection lies in the John Nevins Andrews letters there are other elements of this collection which make it significant.

There is considerable Andrews family biographical information from before John's time to several generations after him. John's grandson and his wife, Dorothy Spicer, wrote extensively to her parents describing missionary life on the frontier. This collection includes 155 of those letters. There are also documents associated with pioneering missionary activities in China.

Beyond the letters there are also extensive manuscripts related to the Andrews and Spicer families. These are generally located in the "Writings" section of the collection. These manuscripts were probably written (or re-written) largely by Helen Spicer-Menkel. John and Dorothy may have written some, but it appears to be largely the work of Helen Menkel.

There are several folders which contain documents related to Adventist missions primarily in Europe. These folders include articles written by John Andrews which appeared in the *Review and Herald*, and also articles by James White and others. This is undoubtedly an incomplete collection for the given time period.

A large section contains biographical materials. Helen Spicer-Menkel was something of a writer. In this mode she hand wrote scores of pages of biographical materials on the Spicer and Andrews family. Unfortunately, there appears to be not one complete manuscript. This collection of manuscript pages came to the Center in a very poor state of order. There can be four or five pages with nearly identical text—starting and stopping at different points—but it is not in relationship with other pages written around the same time. This obviously makes imposing a semblance of order very difficult. The processor has labored to bring as complete a set of the various manuscripts together as possible. It may be that in the confusion of multiple copies and incomplete runs of pages that some pages are out of order or not placed with the proper "edition" of the manuscript. The researcher needs to be aware of this situation and adjust their expectations and research accordingly.

An attempt was made during processing to bring together as complete a set as possible. However, as noted above, this was not always possible. The folders usually contain at least a partial set and then numerous loose pages which appear to go with the general topic of the folder. The stapled pages either clearly go together or appear to be from the same "edition."

In Box 10 is the Dorothy Spicer Andrews Story. Many of the folders contain a generally complete manuscript plus other loose pages which, according to the notation on them, should be with the particular chapter. Even the more or less complete manuscript grouping may not actually be complete. Some of the sections appear to be diary entries while others appear to be straight manuscript. We assume Dorothy wrote these though what the involvement of her sister, Helen Spicer-Menkel, was we do not know.

Throughout the biographical/manuscript portions of the collection are many pages with a notation like this: "Book 7 page 3." It is uncertain what this refers to, however, it is likely that Helen Spicer-Menkel was compiling some type of book set which was to include these stories and devotional writings. By the time the collection came to the Center for Adventist Research only one "book" remained—see Box 10 Fld 45. Even that book appears to be in rough draft condition. The book contains over a dozen stories comprising about 35 pages of handwritten manuscript.

Arrangement

The collection was not well organized when it was received. The arrangement is what was imposed on it by the processor. The collection is divided into four main sections with subsections. The main sections are:

- Personal Documents
- Correspondence
- Writings
- Tibet.

Within each section the folders are arranged by person and then in a somewhat chronological arrangement. The letters are strictly chronological.

There are a number of oversize items. They are located in boxes 3, 4, and 5. The oversize items are shown in this register in their proper sequential location within the collection with the box and folder number indicated along with the notation [see oversize].

The photographs, artifacts, and books are not kept with the collection, but are placed in the respective material type collection locations—photographs with the photograph collection, etc. Center personnel can help you see a list of these items.

Dorothy seemed quite faithful in writing frequently, so the gaps indicate missing letters.

The collection contains hundred of Andrews and Spicer family photographs. Some date to very early daguerreotype photographs from the 1850 or 1860s. A number of these books were retained in the Center's collection and may be found by doing a title search for "John Andrews Library" or for "William A. Spicer Library." Books with no ownership designation may or may not have been retained depending on the Center's needs.
