If you feel changes need to be made to the data uploaded to your FAFSA, please contact our office for further instructions. **If you did not or could not use the IRS Data Retrieval in the FAFSA, you must request a Tax Return Transcript of your (and/or your parent's/spouse's) federal income tax return.** You can order a Tax Return Transcript at [www.irs.gov](http://www.irs.gov) or go to your nearest IRS office. You may be selected for a process called "Verification" and then be required to provide additional documentation. Please log in to your [AU finVue](#) account and check for additional requirements.
