
tunities to decide answers.

#### National AAF Conference Welcomes Artists

he Association of Adventist Forums Conference in Loma Linda, March 15-18, will include an exhibit of paintings done by four artists new to the Adventist art scene. Ranging from geometric abstracts to realistic portraits the paintings will offer something of interest for all who see this exhibit.

Other art will be displayed at the conference. The work of a class taught by Alan Collins, a sculptor at Loma Linda University, will be seen during the Sabbath morning worship service. Featured in a recent issue of *Spectrum* (December, 1983), the sculptures, human-sized candlesticks symbolically portraying the seven churches of Revelation, will occupy the platform of the University Campus Church. Reproduction of children's drawings will also be featured during an unusual worship service planned by Charles Teel, Jr., professor of Christian Ethics at Loma Linda University.

In addition to art, the conference will feature speakers from Oxford University, Newsweek magazine, the U.S. Department of State, the Bishop of Mexico, the University of Bridgeport, as well as

The artists whose work will be coming from different parts of the United States and Canada will demonstrate in their work a variety of styles and influences.

#### Portland Oregon Chapter Studies Church Authority

ith the help of the local conference, the Portland, Oregon Chapter of the Association of Adventist Forums conducted, December 9 and 10, a seminar series on the topic of the church.

E. C. Beck, president of the Oregon Conference, spoke on Friday evening on the basis of authority for Adventist conference administration. Beck stated that the denomination must take a pragmatic approach to organization and authority. He stressed that adequate and open communication lines between each conference and its constituents must be maintained. As a result of his belief, Beck sends out a newsletter to constituents in order to prepare them for conference meetings.

Saturday, Herman Bauman, the ministerial secretary of the conference, discussed the authority of the local church. He fielded questions from a panel of three: Dan Patchin, a physician; Darryl

Ward, a businessman; and B. J. Christiansen, pastor of Portland's Sunnyside SDA Church. Discussion was then opened to the approximately 100 who attended. According to Bauman, the authority of the local conference and all other levels of church organization is derived from the local church.

William Taylor, president of the Portland Chapter, is pleased with the meetings and the members' responses. With assistance from John Brunt, regional representative for the North Pacific Region on the board of the Association of Adventist Forums, William Taylor plans to present subsequent presentations on the subjects of affirmation of Adventist faith in Jesus and commitments to the SDA Church.

# New Year, New Chapters in West and Midwest

The Association of Adventist Forums welcomes three new chapters into the organization. The East Bay Chapter in California, the Greater Battle Creek Chapter in Michigan, and the Southern Oregon Chapter have already held meetings discussing diverse topics ranging from reorganizing church structure to genealogies in Genesis.

Brantley Johnson, acting president of the East Bay Chapter in California, was prompted into forming a chapter by a need for more vigorous discussion of current issues before the church and by the need for more lay participation in the making of church policy. The Pleasant Hills Church is the location of chapter meetings. Attendance has risen to 150.

On January 28, the East Bay Chapter began the new year with a task force report given by Dr. James Walters of Loma Linda University, Dr. Adrian Zytkoskee of Pacific Union College, and Dr. Ordell Calkins of California State University. mission, revealed his findings on reorganizing church structure.

Timothy Spruill organized the Greater Battle Creek Chapter in Michigan because he felt the church needs free, open thinking in addition to traditional historic Adventism. Many of the chapter members have recently moved from other areas, where they were active members of a local AAF chapter, and they wished to continue their growth at Battle Creek. Attendance at meetings vary from 50-60 members. Speakers have included Dr. Ron Graybill from the E. G. White Estate discussing Ellen White, and Dr. Richard Schwarz from Andrews University discussing SDA history. Question and answer periods followed both presentations. Future plans are not concrete, however, there are hopes for joint ventures with the Andrews University Chapter. The officers of the Greater Battle Creek Chapter include Timothy Spruill, president; Bruce Nicola, vice president; Rita Corke, secretary; Dale Corke, treasurer; Karen Spruill, publicity secretary; and Jerry Yeast, program coordinator.

The Southern Oregon Chapter was formed because the president, Donald Casebolt, had previously been attached to other forum chapters and felt a need for one in the Roseburg, Oregon area. Meetings have included informal discussions of Spectrum articles and articles Casebolt wrote on the genealogies of Genesis for Origins. Plans for next year include discussion of the historical background for the 1260 days prophecy. Officers for the Southern Oregon Chapter are Donald Casebolt, president; Joe Salidino, vice president; Dr. Jack Lott, publicity secretary; and Dr. Melvin

Yeo, treasurer.

Couperus found that Southern Pacific Forum members were interested in knowing about discussions taking place in the American and European Forums, and in how various chapters could communicate more effectively with each other and the church. According to Couperus, the problem most mentioned by those in the Southern Pacific Division was a lack of openness or willingness on the part of church administrators to discuss problems, and an intolerance of any degree of variation in thought. Some Forum members said that freedom of discussion has been lost in the church and excommunication has often taken place (see Forum, June 1983). However, with a new divisional leadership coming to power, there is now hope that a Christian spirit of fellowship and communication will become more prevalent in the Southern Pacific Division.
