#### COURSE DESCRIPTION

The history of concepts characteristic of Seventh-day Adventism, such as the Sabbath, sanctuary, conditional immortality, and pre-millennial historicist eschatology, and others, as taught through the centuries, with principal emphasis on their development outside of Seventh-day Adventism.

<u>For this course</u>: A study of the Sanctuary doctrine: A study of the historical development of the sanctuary doctrine in history in general and Seventh-day Adventist Theology in particular.

#### Antes del Intensivo:

1- Reading/Lecturas: In this course, learning occurs through reading, study, and reflexión. Students will prepare for class sessions by reading the required texts for this course. Students, at the begining of the class, will sumbit a reaction paper to Roy Gane's book Altar Call of 6 to 7 pages. It is not simply symmarizing some content of the book, but students should seriously engage with specific ideas of the book, that could be potentially theological helpful or challenging. En este curso, aprendizaje ocurre por medio de la lectura, el estudio y la reflexión. Los estudiantes se prepararán para las secciones de clases al leer los textos requeridos para el curso. Los estudiantes, al principio de la clase, someterán una reacción crítica al libro de Roy Gane, Altar Call, de 6 a 7 páginas. No es simplemente una sumarización de parte de contenido del libro. En lugar de ello, los estudiantes deben seriamente reflexionar con ideas específicas del libro que pueden ser potencialmente de ayuda o desafiantes. Due/Completado, Sunday/Domingo 6, January/Enero, 2019.

#### **Durante la clase:**

1- Midterm take-home Synthesis/Sintesis de período para la casa: During the intensive week, the student will receive a take-home synthesis or reflection paper on the pre-advent judgment. The question is: How is the pre-advent judgment as thaught by SDA's relevant to your own life, your family's life, and the life of the church?/Durante la clase intensiva, los estudiantes recibirán una pregunta para escribir una reflexión sobre el concepto del juicio pre-advenimiento. La pregunta es: De que maneras el juicio pre-advenimiento como es enseñado por los Adventistas del Séptimo Día es relevante para tu vida, para la vida de tu familia, y para la iglesia?. Due/Completado, Thurday/Jueves 10, January/Enero, 2019.

## Después del Intensivo:

- 1- Sermons/Sermones: The students will prepare three high-quality topical sermons on the sanctuary doctrine with an emphasis on evangelism. The sermons should be a clear exposition of the concepts of the sanctuary. Do not use technical theological terminology (e.g., type and antitype), SDA jargon, or quotations from Ellen G. White. Keep your sermons focused on the topic of the sanctuary from the biblical text presenting clearly the teaching of the Seventh-day Adventist Church/Los estudiantes prepararán tres sermones de tópico de calidad sobre la doctrina del sanctuario con énfasis evangelítico. Los sermones deben ser una clara exposición de los conceptos del santuario. No debe usar lenguaje técnico (ej. tipo y antitipo), argot adventista, o citas de Elena G. White. Mantenga su sermón enfocado en el texto bíblico sustentando la doctrina del santuario como es enseñada por los Adventistas del Séptimo Día. Due/Completado, Thurday/Jueves,, 20.
- 2- Seminars/Seminarios: The students will prepare three high-quality seminars on the sactuary doctrine with an emphasis on teaching. The seminars should be a clear expositions of the biblical, theological, and historical concepts of the sanctuary. Make sure to use relevant bibliography from the SDA pioneers, Ellen G. White, and adventist theologians for your seminars. Choose topics on the sanctuary doctrine that are an issue for your local congregation/Los estudiantes deben preparar tres seminarios de calidad sobre la doctrina del santuario con un énfasis en la enseñanza. Los seminarios deben ser una clara exposición de los conceptos del santuario desde una perspectiva bíblica, teológica e histórica. Use fuentes bibliográficas relevantes de los pioneros adventistas, Elena G. White, y otros teólogos adventistas para sus seminarios. Escoga los tópicos sobre la doctrina del santuario que son

#### **Teacher Tardiness**

"Teachers have the responsibility of getting to class on time. If a teacher is detained and will be late, the teacher must send a message to the class with directions. If after 10 minutes no message has been received, students may leave without penalty. If teacher tardiness persists, students have the right to notify the department chair, or if the teacher is the department chair, to notify the dean". *AU Bulletin* 

### **Class Absences**

"Whenever the number of absences exceeds 20% (10% for graduate classes) of the total course appointments, the teacher may give a failing grade. Merely being absent from campus does not exempt the student from this policy. Absences recorded because of late registration, suspension, and early/late vacation leaves are not excused. The class work missed may be made up only if the teacher allows. Three tardies are equal to one absence.

Andrews University takes seriously all acts of academic dishonesty. Such acts as described above are subject to incremental discipline for multiple offenses and severe penalties for some offenses. These acts are tracked in the office of the Provost. Repeated and/or flagrant offenses will be referred to the Committee for Academic Integrity for recommendations on further penalties. Consequences may include denial of admission, revocation of admission, warning from a teacher with or without formal documentation, warning from a chair or academic dean with formal documentation, receipt of a reduced or failing grade with or without notation of the reason on the transcript, suspension or dismissal from the course, suspension or dismissal from the program, expulsion from the university, or degree cancellation.
