




The Summary of Benefits and Coverage (SBC) document will help you choose a health plan. The SBC shows you how you and the plan would share the cost for covered health care services. **NOTE: Information about the cost of this plan (called the premium) will be provided separately. Important Questions	Answers	Why This Matters:
<b>What is the overall <u>deductible</u>?</b>	<b>\$650</b> individual/ <b>\$1,300</b> family for Preferred Network. <b>\$3,000</b> individual/ <b>\$6,000</b> family for Out-of-Network.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your <u>deductible</u>?</b>	<b>Yes.</b> Breast pumps, chiropractic, Cologuard medical & preventive, flu shots and immunizations for all Networks. Outpatient office visits & services and preventive care & services for Preferred Network.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . <b>Are there other <u>deductibles</u> for specific services?</b>	<b>No.</b> There are no other specific <u>deductibles</u> .	You don't have to meet <u>deductibles</u> for specific services.
<b>What is the <u>out-of-pocket limit</u> for this <u>plan</u>?</b>	<b>\$6,000</b> individual/ <b>\$12,000</b> family for Preferred Network. Includes pharmacy. <b>Not applicable</b> for Out-of-Network.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
<b>What is not included in the <u>out-of-pocket limit</u>?</b>	Penalties, ineligible charges, premiums, balance-billed charges and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
<b>Will you pay less if you use a <u>network provider</u>?</b>	Yes. See <a href="http://www.accesshma.com">www.accesshma.com</a> or call 1-833-865-0141 for a list of network providers.	This <u>plan</u> uses a <u>provider network</u> . You will pay less if you use a <u>provider</u> in the <u>plan's network</u> . You will pay the most if you use an <u>out-of-network provider</u> , and you might receive a bill from a <u>provider</u> for the difference between the <u>provider's</u> charge and what your <u>plan</u> pays (balance billing). Be aware your <u>network provider</u> might use an <u>out-of-network provider</u> for some services (such as lab work). Check with your <u>provider</u> before you get services.

<b>If you need help recovering or have other special health needs</b>	<a href="#">Home health care</a>	20% coinsurance	40% coinsurance	Preauthorization is required. Limited to a 90-visit plan year maximum.
	<a href="#">Rehabilitation services</a>	20% coinsurance	40% coinsurance	Preauthorization is required for inpatient and limited to a 30-day plan year maximum. Outpatient is limited to a 50-visit plan year maximum. Swim therapy is covered.
	<a href="#">Habilitation services</a>	20% coinsurance	40% coinsurance	Habilitation services, including neurodevelopmental therapy and rehabilitative therapies for the treatment of autism, are covered under the Outpatient Rehabilitation Services benefit. ## Excluded Services & Other Covered Services:

### Services Your [Plan](#) Generally Does NOT Cover (Check your policy or [plan](#) document for more information and a list of any other [excluded services](#).)

- Acupuncture
- Bariatric surgery
- Cosmetic surgery
- Dental care (Adult)
- Long-term care
- Routine eye care (Adult)
- Routine foot care (except if medically necessary)
- Weight loss programs

### Other Covered Services (Limitations may apply to these services. This isn't a complete list. Please see your [plan](#) document.)

- Chiropractic care (12-visit plan year maximum)
- Hearing aids (Limited to a \$2,500 maximum per ear every 2 plan years)
- Infertility treatment (includes diagnosis & treatment of underlying cause only, limited to a \$3,000 lifetime maximum)
- Non-emergency care when traveling outside the U.S.
- Private-duty nursing (limited to a 60-hour plan year maximum)

**Your Rights to Continue Coverage:** There are agencies that can help if you want to continue your coverage after it ends. ### Does this plan provide Minimum Essential Coverage? **Yes**

**Peg is Having a Baby**  
(9 months of in-network pre-natal care and a hospital delivery)
