

KEYNOTE SPEAKERS



Tyler J. VanderWeele, PhD, is the John L. Loeb and Frances Lehman Loeb Professor of Epidemiology in the Departments of Epidemiology and Biostatistics at the Harvard T.H. Chan School of Public Health, and director of the Human Flourishing Program and co-director of the Initiative on Health, Religion and Spirituality at Harvard University.

He holds degrees from the University of Oxford, University of Pennsylvania, and Harvard University in mathematics, philosophy, theology, finance and biostatistics. His methodological research is focused on theory and methods for distinguishing between association and causation in the biomedical and social sciences and, more recently, on psychosocial measurement theory.

His empirical research spans psychiatric and social epidemiology; the science of happiness and flourishing; and the study of religion and health. He is the recipient of

the 2017 Presidents' Award from the Committee of Presidents of Statistical Societies (COPSS). He has published over 400 papers in peer-reviewed journals; is author of the books Explanation in Causal Inference (2015), Modern Epidemiology (2021), and Measuring Well-Being (2021); and also writes a monthly blog posting on topics related to human flourishing for Psychology Today.



David R. Williams, PhD, is the Florence Sprague Norman and Laura Smart Norman Professor of Public Health and chair of the Department of Social and Behavioral Sciences at the Harvard T.H. Chan School of Public Health. He is also a professor of African and African American Studies and Sociology at Harvard University. Previously, he served six years on the faculty of Yale University and 14 at the University of Michigan. He holds an MPH from Loma Linda University and a PhD in sociology from the University of Michigan.

Williams is an internationally recognized social scientist focused on social influences on health. He has been invited to keynote scientific conferences in Europe, Africa, Australia, the Middle East, South America and across the United States. His research has enhanced our understanding of the complex ways in which socioeconomic status, race, stress, racism, health behavior and religious

involvement can affect health.

He is the author of more than 475 scientific papers, and he has served on the editorial board of 12 scientific journals and as a reviewer for over 75 others. The Everyday Discrimination Scale that he developed is the most widely used measure of discrimination in health studies.



Daniel Ganu, DrPh, is Professor of Public Health, Adventist University of Africa. Ganu is the principal investigator for Adventist Health Study in Africa, chair of AHSRA-Africa and editor-in-chief of the Pan African Journal for Health & Environmental Science.

THEME: INTERNATIONAL RESEARCH

TITLE: "Blooming After the Storm: Transforming Women's Lives Through Education" *Gianina Petre (Adventus University, Romania), Arceli Rosario (AIIAS)*

ABSTRACT: Using the empowerment education framework (Freire, 1970) and transformative learning theory (Mezirow, 1978), we studied the lives of six Adventist Romanian women through narrative inquiry. The participants' stories went through the process of data metamorphosis and data representation (Muccio, Reybold, & Kidd, 2015). Recurrent metaphors and motifs are real world vs. desired world, emptiness vs. completeness, internal storm vs. external storm, transformation vs. stagnation.

TITLE: "Lived Experiences of Adventist Humanitarian Service Providers in the Ukraine-Russia Crisis: A Hermeneutic Phenomenological Study" Arceli Rosario, Pavel Zubkov, David Lumowa, Gracel Ann Saban, Jasmin Tuapin (Adventist International Institute of Advanced Studies)

ABSTRACT: The ongoing armed conflict in Ukraine has become a serious humanitarian crisis. The call for help to meet the basic needs of people affected by the crisis has been disseminated worldwide. Several organizations such the "Adventist Development Relief Agency (ADRA) staff report that conditions within Ukraine are even more dire than the rest of the world is seeing in the media" (ADRA's Response to the Ukrainian Crisis, para. 4). ADRA has to suspend its ongoing projects to prioritize the emergency humanitarian assistance for the displaced victims. **TITLE:** Differences in Practices of Personal Spirituality and Beliefs Concerning Salvation between Adventist Teachers in Argentina, Australia, Brazil, Korea, Philippines, the Solomon Islands, Russia, Ukraine, the United States and Zimbabwe *Robert K. McIver, Wendy A. Jackson (Avondale University)*

ABSTRACT: The differences between the survey responses from Adventist teachers in Argentina, Australia, Brazil, Korea, Philippines, the Solomon Islands, Russia, Ukraine, the United States and Zimbabwe regarding practices of personal spirituality and understanding of salvation are explained by underlying cultural differences.

THEME: HEALTHCARE

TITLE: "Implementing Artificial Intelligence- based Solutions in Adventist Healthcare Institutions: An Extended Technology Acceptance Model" *Kepha Pondi (Adventist International Institute of Advanced Studies), Kennedy Orwa (University of Sussex)*

ABSTRACT: Healthcare service providers are increasingly using Artificial Intelligence-based solutions to discover new drugs, expand access to healthcare services, improve patient outcomes, and anticipate and control the spread of diseases. This study extends Technology Acceptance Model and proposes strategies to accelerate the adoption of AI-based solutions in Adventist healthcare facilities. **TITLE:** "The Structure of Clinical Ethical Decision-Making: An AdventHealth Needs Assessment Study" *Edwin Hernandez, Leana Araujo, Martin Shaw (AdventHealth University)*

ABSTRACT: The primary purpose of this study is to conduct a needs assessment of the bioethics infrastructure within AdventHealth hospitals, to better understand and strengthen this infrastructure. The study had a mixed method. cross-sectional design, using an anonymous online survey. To obtain varied points of view, the survey was sent to five key leaders from each hospital facility: the chief executive officer, chief medical officer, chief nursing officer, risk manager, and lead chaplain. Survey questions focused on the composition, structure, function, and effectiveness of clinical ethics committees within AdventHealth and the issues they encounter. Respondents rated the effectiveness of their facilities' bioethics. infrastructure and shared information about ethics-related training and resources.

TITLE: "What Is the Level of Domestication of The Human Rights to Water and Sanitation in Kenya? Insights From a United Nations University Leave No One Behind (LNOB) in Water Sanitation and Hygiene (WASH) Status Report for Kenya" Japheth Nzioki (College of Health Sciences of Jumeira University-Dubai, United Arab Emirates)

ABSTRACT: Key elements of Human Rights to Water and Sanitation (HRWS) are classified into two; Five normative criteria (availability, accessibility, acceptability, affordability, and quality,) and five principles (equality and non-discrimination, accountability, sustainability, participation, and information access and transparency). This study presents a review of the domestication of HRWS in legislations and institutions in Kenya.

THEME: COVID-19

TITLE: "Vaccine Hesitancy at Andrews University" *Melinda Nwanganga, Janae Mitchell, Jimmy Kijai, Mordekai Ongo, Shawna Henry (Andrews University)*

ABSTRACT: In February 2022, using the Class Climate platform, we investigated reasons why students, staff and faculty at Andrews University received or did not receive the COVID-19 vaccine. Three hundred ninety-four (394) participated: students (47.4%), staff and faculty (48.4%), and others (4.1%). Significant differences in reasons were found between vaccinated and unvaccinated.

TITLE: "Are You Pro or Against COVID-19 Vaccine? Closer Look at North American Division Members' Attitudes" Angeline Brauer (NAD), Petr Činčala (Andrews University), Injae Son (Western Michigan University)

ABSTRACT: This presentation highlights findings from research conducted in the North American Division (NAD) regarding members' attitudes about and receipt of the COVID-19 vaccination. The research identified trends based on different demographic factors, including gender, age, race or ethnicity, education, religious or political views, church location or size, or the Union to which the recipient belongs. The study also identified reasons for vaccination hesitancy through the demographic analysis.

TITLE: Lifestyle factors focused on potential antiviral and immune-enhancing herbs and spices used globally to treat COVID-19 *Padma P. Tadi Uppala (Andrews University)* **ABSTRACT:** The purpose of this study is to examine lifestyle factors used globally against the virus SARS CoV-2. Results indicate that lifestyle factors such consumption of herbs and spices, exercise, hydrothermal therapy and prayer that enhance the immune system, possibly play a significant role in controlling mortality rates from COVID-19.

THEME: MENTAL HEALTH

TITLE: "I struggled with depression, self-injury, and was suicidal": How Religious Practices Help LGBTQ+ Adventist Millennials Shannon M. Trecartin, Curt VanderWaal, David Sedlacek (Andrews University), Rene Drumm (University of Southern Mississippi)

ABSTRACT: This presentation examines the role of substance use and religiosity/ spirituality as risk and protective factors for depression, suicidality among LGBTQ+ Seventh-day Adventist Millennials. Results suggest that religious participation may buffer some mental health challenges and selfharm, while significant concern remains for those who identified as transgender or gender diverse.

TITLE: "The P.E.A.R. Strategy: Addressing Mental Health in Girls" *Leanne Marie Prendergast, Joel Raveloharimisy* (Andrews University)

ABSTRACT: The P.E.A.R. Strategy (Prevention, Engagement, Action and Resilience) existing methodologies in chronological order is a practical evaluation tool which uses to address mental health disorders such as depression and anxiety in girls. TITLE: "Not a Needy Person Among Them: A Network Analysis of Prosocial and Religious Behaviors" *Karl Bailey, Zoe Shiu, Shannon Trecartin, Duane*

ABSTRACT: We used a network analysis of prosocial and religious behaviors to identify facilitating hub items that might drive broad prosocial behaviors among church members. We identified four hub items that suggest that intentional involvement of church members in service to the church and community might serve to drive further prosociality.

TITLE: Corelates of Legalism in a Global Sample of Seventh-day Adventists Duane C. McBride, Alina Baltazar, Karl G. Bailey, Shannon Trecartin (Andrews University), David Trim (GC Office of Archives, Statistics and Research)

ABSTRACT: The Seventh-day Adventist Church is often identified as a strict church (Iannaccone, 1994: Chen et al., 2019: McBride et al., 2020) in that it has specific dietary and behavioral requirements for joining and continued membership. These include abstinence from alcohol, tobacco, and illicit drugs as well as a strong emphasis on vegetarianism (McBride et al., 2020). This has resulted in longevity advantage for Adventists (Fraser et al., 2020). This focus on behavioral requirements have resulted in critics viewing Adventists as legalists (WELS, 2022). The purpose of this research is to examine the issue of legalism among Adventist Church members.

TITLE: "A Garland and a Chain: The Persistent Influence of Family Religious Environment on Adult Adventist Church Members Raised in the Church" *Karl Bailey, Myrnaliza Tan, Alina Baltazar, Duane McBride (Andrews University)*

ABSTRACT: Adventist church members across the globe born into an Adventist church context report a stronger family religious environment than those who joined later, along with stronger agreement with Adventist beliefs, lower spiritual struggle and less legalism. Childhood family religious environment plays a protective role into adulthood for Adventist-born church members.

Finally, the study explored how students prepared for life after high school as they navigated through their senior year. Students shared what was helpful to them during this time and the advice they would offer to the junior class.
