**TITLE/AUTHOR: "Social aspects in articles** from the Review and Herald magazine written by Adventist missionaries in Mexico from 1891 to 1914"

**ABSTRACT:** The Seventh-day Adventist Church had its beginnings in Mexico in the late 19th century with the arrival of a small interdisciplinary group of missionaries. Some of these missionaries sent reports that were disseminated in various church publications, especially in The Advent Review and Sabbath Herald magazine (abbreviated Review & Herald, now Adventist Review), which is the church's official organ. In these articles, the missionaries, among whom George Caviness stands out, reported on the progress of the church's development in the country and described the social situation and some aspects of Mexico's history and politics. Additionally, they recounted experiences that shed light on the personal and familial lives of the missionaries.

#### **TITLE/AUTHOR: "Budget Deficit and Bank's Dividend: A Case Study of Ghana Commercial Bank Plc.**"

**ABSTRACT:** The paper estimates the impact of the budget deficit on the dividend of Ghana Commercial Bank. The study makes use of the Autoregressive Distributed Lag model (ARDL) on time series Data, for the period 2000--2020. The data set on dividend, budget deficit, profitability, interest rate, and inflation rate were tested for stationary using ADF and PP tests and established stationarity at levels and first difference for the variables. ARDL test results revealed that in the long run, budget deficit and profitability have a positive relationship with the bank's dividend with

a significant influence which conforms with the crowding out arguments. The short-run period shows a positively insignificant relationship between profitability and dividends. There is also a unidirectional causality between budget deficit and dividends. The possible reason for the result could be due to the government's persistent borrowing which increases the deficit hence a positive relationship between the budget deficit and dividend of Ghana Commercial Bank. The study recommends that even though a high deficit impacts positively on dividends, the government should adopt fiscal policies that can reduce the deficit since its impacts on other economic variables are detrimental.

**ABSTRACT:** This study focuses on raising awareness about the stark social reality faced by orphans due to femicide in Mexico, employing the participatory methodology of photovoice in collaboration with the Civil Association "Futuro con Derechos." From a qualitative methodological perspective with a conception of an experiential epistemic approach, anchored in socio-critical and pragmatist investigative paradigms, it is framed within social constructionism to understand and interpret the poignant meanings attributed to the harrowing realities of children in situations of extreme vulnerability. The photovoice methodological design has empowered the participants to eloquently express their poignant experiences through evocative photography, granting them voice and agency in the heartrending narrative of their dire circumstances.

**ABSTRACT:** This study examines the application and significance of financial analysis indicators within religious organizations through the perspectives of Chief Financial Officers (CFOs). Utilizing a qualitative research design, interviews were conducted with six CFOs of the Seventh-day Adventist Conferences in Madagascar, focusing on how these professionals perceive and implement financial analysis in their managerial practices. The research highlights the essential role that financial analysis plays in aligning organizational strategies with financial realities, ensuring sustainability, and fostering informed decisionmaking. It discusses the strategic integration of financial analysis into daily management practices, demonstrating how they help CFOs navigate the complexities of financial stewardship within religious contexts. Findings indicate that financial analysis is crucial for evaluating performance, managing resources effectively, and maintaining transparency and accountability, all of which are vital for securing trust and compliance within religious non-profit environments. The study enriches the literature on financial management in non-profits by detailing the specific uses and benefits of financial analysis in the unique context of religious organizations, providing insights that could enhance organizational practices and stakeholder engagement.

**ABSTRACT:** We investigated the tithing behavior of Adventists in Indonesia. Conveniently selected church pastors were asked to distribute an online tithing behavior questionnaire to their congregations. We received 355 complete responses. Tithing intention strongly influenced tithing behavior and that religiously committed Adventists are more likely to tithe.

#### **TITLE/AUTHOR: "The Role of Social Media** in Advancing the Mission of the Seventh-day Adventist Church"

**ABSTRACT:** This study investigates the role of social media in advancing the mission of the Seventh-day Adventist Church. It explores the impact of various aspects of social media use, including religious engagement, positive and negative experiences, and general usage, on the frequency of witnessing to non-Adventists in the community.

THEME: SOCIAL DYNAMICS AND MENTAL HEALTH

#### **TITLE/AUTHOR: "Moderated Mediation Study** on the Factors affecting Mental Health Care Seeking Among University Students in Kenya" Odhiambo, Janet Nyaboke

**ABSTRACT:** Mental health issues have become global public health concerns in recent time. Yet, in Kenya five out of six people who suffer from mental health issues do not seek help. This paper sort to uncover the moderating effect of demographic profile (Age, gender, & family structures) and the mediating effect of intention to seek help between the determinants of mental health and help seeking behavior among university students. This study used a quantitative methodology employing a Structural Equation Modelling (SEM) design. Six hundred and sixteen respondents from eight universities each representing the eight regions in Kenya participated in the study. Multi-stage sampling was used to select regions, universities, and clusters of students. The study was anchored in the Theory of Planned Behavior and the Social Ecological Model. The findings suggested that intention to seek help fully mediated the relationship between sociocognitive factors and mental health care seeking sources. Moreover, intention partially mediated healthcare infrastructure and mental health care seeking sources. The results also showed that sex and family structures played a moderating role in the relationship among the independent and dependent variables. Finally, a new model that emerged was proposed as a resource for developing public health education programs that may be used for intervention purposes.

**TITLE/AUTHOR: "The Association of Depression, Suicidal Ideation, and Spiritual Beliefs: A comparison of the Chinese Union** Mission and the North American Division" Cincala, Petr; Drumm, René; Son, Injae

**ABSTRACT:** This presentation highlights two cohorts of the Global Church Members Survey participants: the Chinese Union Mission and the North American Division regarding anxiety, depression, and spiritual beliefs. CHUM respondents (47%) reported higher levels of feeling down, depressed, or hopeless compared to NAD's 24%. Similar patterns were observed in suicidal thoughts, attempts, and self-harm. The connection between anxiety, depression, and spiritual beliefs reveals that CHUM respondents who experienced a loss of spiritual meaning or shaken faith reported

increased rates of negative feelings. Recognizing these disparities is crucial for church leaders to provide tailored mental health care, emphasizing the impact of cultural context and spiritual practices on participants' well-being.

**ABSTRACT:** This presentation offers insights into the experiences of female pastors regarding ordination into ministry. In-depth interview data with 21 female pastors in the North American Division reveals key differences between commissioning and ordination. These include patterns of harm such as being considered inferior pastors, feeling invisible to Church administrators, and sensing ongoing confusion about roles. This study is important in clarifying the issues of women's ordination from the perspective of those most affected by Church policies.

**TITLE/AUTHOR:** "Disseminating Intimate **Partner Violence prevention and intervention** work in the church: What we've done and what's still needed" Ponce-Rodas, Melissa; Drumm, René

**ABSTRACT:** This presentation shares data from four studies of Intimate Partner Violence (IPV) in the Adventist Church. The findings reveal patterns of abuse on par with national rates pointing to the need for widespread intervention. **TITLE/AUTHOR:** "Teachers' Accountability for Student-centered Learning in Adventist Secondary Schools in West Kenya Union Conference: Toward Better Learning Outcomes" *Role, Elizabeth M.* 

**ABSTRACT:** This study probes the association of teachers' accountability for designing a student-centered curriculum with student's academic achievement in the Adventist secondary schools in the western Kenya region. It was found that teachers in high-performing schools are more accountable for student-centered learning implying that accountability results in better learning outcomes.

**TITLE/AUTHOR:** "Using Interdisciplinary **Trauma-Informed Approaches to Modify University Courses and Departments: First Year Findings and Program Revisions**" *Young, Dustin* 

**ABSTRACT:** Five interprofessional programs at Andrews University collaborated in the development of a campus-wide initiative to infuse trauma-informed approaches (Palmer, 2020) into undergraduate courses. The Attitudes Related to Trauma-Informed Care Scale 45 (ARTIC-45) was used to measure longitudinal faculty outcomes in this two-and-a-half-year, mixed-methods study. Initial findings, needed adjustments, and campuswide responses will be presented from the first year of this study.

**ABSTRACT:** This study was conducted to assess the needs, demand and uptake of the OT upgrade programs in Kenya. Quantitative exploratory design was utilized targeting Practising OTs with diploma (Group 1) and OTs who have either graduated or enrolled in an upgrade degree program (Group 2). The study revealed a significant difference between the G1 and G2 groups t (23) = -2.769, p = .008 at p < .05 in the knowledge and competency levels.
