## PRESENTER PROFILES



**Harvey Burnett, PhD**, Chair, School of Social & Behavioral Sciences and Professor of Psychology, is a licensed psychologist, was also a staff psychologist at the Andrews University Counseling & Testing Center for over six years where he coordinated the Center's Substance Abuse and Campus Outreach programs. Dr. Burnett is the past president of the Michigan Crisis Response Association and he serves as the clinical director and board member of the Berrien County Critical Incident Stress Management (CISM) for over 15 years. He also provides (CISM)

for over 15 years. He also provides CISM interventions to victims of the World Trade Center attacks after September 11th and the Adventist University in Haiti after the 2010 earthquake. In his community (Buchanan), he has served as a law enforcement officer, Chief of Police, Assistant Emergency Management Coordinator, and Drug Abuse Resistance Education School Liaison Officer and on the School Board. Dr. Burnett is the proud father of three children, and grandfather to two.



**Stacey Nicely, PhD, LP, LPC**, Counseling & Testing Center, Director, and Clinical Assistant Professor in the Department of Graduate Psychology & Counseling. Dr Nicely has served in the Counseling and Testing center for roughly 13 years. A Certified Clinical Trauma Professional, she provides trauma-informed clinical services (therapy and psychoeducational presentations). Her integrated therapeutic approach primarily includes psychodynamic, cognitive behavior therapy, and humanistic/existential therapy. She utilizes other approaches which include solution-focused

brief therapy, positive psychology, aspects of dialectical behavior therapy, and assertiveness and coping skills training. Dr Nicely has presented on mental health related topics at national and international psychological conferences and to denominational and non-denominational audiences locally and internationally. She thoroughly enjoys her work and is passionate about facilitating the multiple processes that contribute to individuals living out their God-given potential and becoming the best version of themselves.



**Karl Bailey, PhD**, Director, Undergraduate Behavioral Neuroscience Program, and Professor of Psychology in the School of Social & Behavioral Sciences. A cognitive psychologist by training, Dr. Bailey's work with his research students on attention and self-control among Seventh-day Adventist young adults led him to the study of the relationship between religious belief and motivation. For the past four years, Dr. Bailey and his students have been working on a large project to develop and refine instruments to study the internalization of Sabbath keeping among Seventh-day Adventists, and to better understand the positive relationship between Sabbath keeping and well-being. Dr. Bailey is married to Rosemary (Bauer) Bailey, and is the father of Lilianora, and Annalise. When not teaching or researching, Dr. Bailey programs computers and plays the guitar, ukulele, autoharp, and bass.
