- a. Undergraduate Council: (4/3/2023). New policy on the use of test scores in admissions. The ACE committee is working on helping students take first year courses in their first year.
- b. Graduate Council: (2/1/2023). Housing situation for short term graduate students. Graduate marketing funding; PDRC items voted; didn't meet in April.
- c. Faculty Policy & Development Council: Did not meet.
- d. Academic Operations and Policy Council:
 - March 13: Discussion of HLC upcoming visit in 2027; review of admissions i. policy for handling test scores and discussion of the impact to scholarships; additional conversations about the need for a tuition revamp.

[6] Academic Integrity and Generative Artificial Intelligence. J.
