**MINUTES** 

The following change to the graduation policy was voted, which reflects a similar action taken by the Graduate Council:

GRADUATION POLICIES 96-97, #11

Students completing a degree program with Andrews University are invited to participate in the graduation ceremonies provided by the University. Students may choose to graduate *in absentia*. Students completing degrees at affiliated sites, may choose to participate in graduation on the main campus at the next appropriate ceremony. Only students completing Andrews University degrees will be permitted to participate in the official graduation ceremonies.

Patricia Mutch presented a report on the scheduling of General Education Classes for the 1997-98 school year (see attached). A potential problem was noted for freshman in departments that require the first year to be all or mostly General Ed offerings. This will not be possible if the courses are only offered at the indicated times.

GENERAL EDUCATION SCHEDULING REPORT

Guidelines for departments completing Academic-year schedules that were sent this year are outdated and needs revision. Arthur Coetzee indicated that his office will work on a revision SCHEDULING POLICIES

Patricia Scott brought a report from the Academic Policies Subcommittee (see attached) regarding admissions policies. The recommendations will be voted on next meeting of the Undergraduate Council. Questions were raised by the council members regarding the basis used for establishing the minimum requirements.

- 1. Admission standards for enrollment be presented in a table; text of <u>Undergraduate Policy</u>
  <u>Manual</u> be edited to reflect the change.
- 2. Move in the direction of using ACT/SAT results for placement tests for English and reading. Linda Closser to supervise ACT/SAT research on correlation of scores and achievement. (Note that only AU, in SDA education system, uses Nelson-Denny reading test.)
- 3. Affirm the use of AU mathematics placement test.
- 4. The Undergraduate Council to receive and review reports from the Deans regarding the admission of students not meeting admission criteria. (There was little support for the establishment of an admissions committee to decide on exceptions.)
- 5. Change admission categories from Regular, Provisional and Probationary to Regular and Probationary only.
- 6. Change minimum scores for Regular Admission from:
  - 2.75 overall GPA or 2.5 overall GPA and college-bound percentile of 35 on ACT/SAT or 2.25 overall GPA and a college-bound percentile of 25 on ACT/SAT
  - To: 2.75 overall GPA or college-bound percentile of 50 on ACT/SAT
- 7. Minimum scores for Probationary Admission to read: 2.25 overall GPA and college-bound percentile of 25 on ACT/SAT.
- 8. Minimum TOEFL score be 550, plus 5 on TWE or minimum of 80 on MELAB for both admission categories.
- 9. Certification: for Regular Admission, add to present: OR 12 quarter credits or 8 semester credits of college general education courses with minimum 2.5 GPA. For Probationary Admission, add to present: OR 12 quarter credits or 8 semester credits of college general education courses with minimum 2.00 GPA.
- 10. Change: "Sign a statement on application agreeing to respect and abide by Andrews rules and standards" to Agree to respect and abide by Andrews standards of conduct. Move the statement in the table from *Character References to Required of both Categories*.

Overseas transcripts are evaluated according to AACRAO (American Association of Collegiate Registrars and Admissions Officers) guidelines - the criteria by which foreign transcripts are evaluated for U.S. equivalency.

GED - General Education Development program whereby students without a secondary-school diploma may complete an equivalency program and receive a GED certificate in lieu of a diploma.

TOEFL (Test of English as a Foreign Language); TWE (Test in Written English); MELAB (Michigan English Language Assessment Battery) - three tests that evaluate English proficiency levels of students from non-English-speaking countries. English programs require higher scores.

The subcommittee recommends the adoption of the following policy:

A student may complete more than one major in fulfilling the requirements for a degree. One of the majors must be designated as the primary major, which will determine the degree the student will receive. The student must complete all the requirements for that major and degree including cognates and core. Most BA and BS majors may be used as secondary majors. Professional degree majors may not be used as secondary majors.
